

**ORDINANCE NO. 2025-02**

**AN ORDINANCE ADJUSTING SALARY FOR VILLAGE COLLECTOR**

**WHEREAS**, the Village Board has reviewed the salaries paid to Village Officials as set forth in the Village Code; and

**WHEREAS**, the Village Board has determined that an adjustment to the salary for the Village Collector is appropriate and should be made as provided herein; and

**WHEREAS**, the Village Board finds that it is in the best interest of the Village to increase the salary for the Village Collector shall be effective beginning June 1, 2025, as provided herein;

**NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF HOPEWELL, MARSHALL COUNTY, ILLINOIS, THAT:**

**Section 1.** Effective beginning June 1, 2025, Title 2, Chapter 2, Section 5.D of the Hopewell Village Code is hereby amended as follows (additions are indicated by underline; deletions by ~~strikeout~~):

**§2.02.05 Village Collector.**

D. Salary: Effective June 1, 2025, the ~~The~~ salary of the Village Collector shall be one hundred dollars (\$100.00) ~~fifty dollars (\$50.00)~~ per month. This salary may be changed or adjusted from time to time by passage of proper ordinance.

**Section 2.** This Ordinance is hereby ordered to be published in pamphlet form by the Hopewell Village Clerk and said Clerk is ordered to keep at least three (3) copies hereof available for public inspection in the future and in accordance with the Illinois Municipal Code.

**Section 3.** This Ordinance is in addition to all other ordinances on the subject and shall be construed therewith excepting as to that part in direct conflict with any other ordinance, and in the event of such conflict, the provisions hereof shall govern.

**Section 4.** If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity of such section, paragraph, clause or provision shall not affect any of the other provisions of this Ordinance.
